The following agreement will be good for 1 year from the acceptance date as found on the Certificate issued, upon approval, and may be renewed annually.

The Applicant agrees to:

- 1) Apply TECH LINE COATINGS, INC., products in accordance with procedures and processes developed by TECH LINE COATINGS, INC.
- 2) Submit samples to TECH LINE COATINGS, INC., as requested, for test and evaluation.
- 3) Correct any deficiencies in processing identified by TECH LINE COATINGS, INC.
- 4) Identify the TECH LINE COATINGS, INC., product, when used, to customer by either its Brand or Trade name.
- 5) In advertising the coating service the Applicant will acknowledge TECH LINE COATINGS, INC. as the supplier of the coatings.
- 6) Only use TECH LINE COATINGS, INC., products on parts supplied by customers referred to Applicant by TECH LINE COATINGS, INC.
- 7) Only use TECH LINE COATINGS, INC., products on customer's parts, sent in to Applicant, requesting a TECH LINE COATINGS, INC., product.
- 8) Not to substitute any coating, not manufactured by TECH LINE COATINGS, INC., for a TECH LINE COATINGS, INC., product.
- 9) Supply Tech Line with a copy of your Liability Insurance policy. The policy must show a minimum of \$1,000,000.00 (One million USD) in coverage.

Nothing in the terms above would prohibit an Applicator from utilizing coatings manufactured by others. Applicator is agreeing that they will not substitute coatings manufactured by others when a TECH LINE COATINGS, INC., product is requested or in response to any advertisement or other public release featuring TECH LINE COATINGS, INC., products. Nor would it prohibit an Applicant from advertising or utilizing a trade name that they have developed for their service.

TECH LINE COATINGS, INC. agrees to:

- 1) Certify companies complying with all the terms and conditions, filling out the requested Approved Applicator Application and submitting the requested samples.
- 2) List the Approved Applicator on a list of Approved Applicators, for referral.
- 3) Refer potential customers to the Approved Applicator(s) nearest to such potential customers.
- 4) Promote such Approved Applicators in advertising through the use of statements such as; "Call for the nearest Approved Applicator", or similar statements.
- 5) Promote and advertise the trade names "CERMAKROME" and "POWERKOTE" as well as their superior characteristics.
- 6) Supply promotional literature designed to support the Approved Applicator program, as it becomes available, only to Approved Applicators.
- 7) Allow only Approved Applicators to participate in contingency programs.

“CERMAKROME”

The following parts must be provided with the application:

- 1) Two short pieces of exhaust pipe coated with Cermakrome and vibratory polished.
- 2) One piece of pipe coated inside and out with MCS and top coated with Cermakrome, if the Applicant wishes to have customers referred to them, needing such a coating or combination of such coatings.

“POWERKOTE”

The following parts must be provided with the application:

- 1) One piston coated on top with CBC2 and the skirts coated with either DFL-1 or TLML.
- 2) One rod or main bearing coated with DFL-1.
- 3) One valve coated with CBC2 on the combustion chamber side and DFL-1 or TLML on the back and stem.

These parts will not be returned. Used, non-functional parts are acceptable. We will be performing destructive tests to the parts to determine proper preparation and bonding of the products.

After examination and approval for the program a copy of the application will be returned to the applicant along with a certificate identifying them as an “Approved Applicator” of TECH LINE COATINGS, INC.

If an applicant wishes to, they may send additional coated parts for our consideration. Such parts would be photographed, but not destructive tested. These parts could be used in future magazine stories dealing with coatings. When ever possible the Approved Applicator would be listed as having provide the coating service. The parts would be returned after photographing. This could be especially beneficial if a company has found a market for coating parts other than exhaust manifolds/headers. New and unusual, appeals to the magazines.
